Treasurer and President-elect of the Kadimah School, and is co-founder
of Jewish Young Professionals of Buffalo; and

WHEREAS, Born with Down syndrome, David Rosenhoch, who graduated from Emerson High School's Hospitality Program and Canisius College's YALT Program, is an inspiration to all; at Temple Beth Zion, he works with the 3 year-olds in the Play and Learn School, and is a volunteer in their Interfaith Mitzvah program; and

WHEREAS, David Rosenhoch also donates his time and energy assisting at St. Benedict's Catholic School, Cradle Beach Camp, SABAH, and a program for soccer for athletes with disabilities, which selected him as their 2013 Volunteer of the Year; he values his independence, and proudly shares a house with six other young men who are living with disabilities; and

WHEREAS, Rare indeed is the impressive dedication shown by individuals for the benefit of others which the Rosenhoch family has displayed throughout their lives; and
