WHEREAS, This remarkable woman spent 72 years in the ministry of education in the Syracuse and Albany Dioceses as a teacher, administrator, and volunteer; and

WHEREAS, In the Syracuse Diocese, Sister Mary Ethna Kapfer taught at St. John the Baptist School and St. Vincent de Paul School, Syracuse; St. Patrick's School, Binghamton; and St. Agnes School, Utica; and

WHEREAS, Sister Mary Ethna Kapfer currently resides in Utica with the Sisters in the Eagle Street Community; she is filled with gratitude for the gift of her vocation; and

WHEREAS, Singular in distinction is Sister Mary Ethna Kapfer, whose service to her church and her people, and her involvement in her community mirror a commitment of compelling dimension; and
