WHEREAS, She has served as the Cancer Chairwoman for the American Legion Auxiliary for 22 years, lending her support and advice to those enduring cancer treatments; and

WHEREAS, In 2015, Lorna Swan was featured in the September issue of the Ladies VFW Auxiliary magazine in recognition of her valued membership and service to the VFW, and for her particularly sunny disposition during her many visits to hospitals and nursing homes; and
