WHEREAS, Globally recognized for his expertise in both coaching and officiating in Special Olympics sports as well as training athletes with disabilities, Neal J. Johnson has served as a Lead Clinician for coaching and officiating sports internationally and has been an International Technical Official at every Special Olympics World Games since 1995; and

WHEREAS, On behalf of people with intellectual disabilities, Neal J.

Johnson has spoken and presented to many corporations and civic organizations as well as multiple levels of government including the New York State Legislature, the United States Congress and the United Nations; and

WHEREAS, In May of 2014, Neal J. Johnson was the recipient of an Honorary Doctorate from St. Bonaventure University in recognition of his four decades of lifelong service and tenacious leadership to those with intellectual disabilities; and

WHEREAS, For the past 43 years, Neal J. Johnson rendered faithful, conscientious and valuable service to Special Olympics New York, Inc., earning the admiration, esteem and affection of his colleagues; and
