WHEREAS, This vital organization's unique blended model aligns county and federal resources to ensure that youth and families have access to comprehensive, innovative, client-centered services in their homes and communities; and

WHEREAS, An ambitious, creative, and responsive organization, Kids Oneida continues to innovate new solutions to community needs; and

WHEREAS, Launched with two staff and one program, Kids Oneida now has 13 initiatives led by more than 300 staff and providers across the Mohawk Valley; and

WHEREAS, Kids Oneida has been instrumental in shifting the landscape of children's services in Central New York and statewide to one that recognizes the value and importance of keeping families together; and

WHEREAS, Over its distinguished 20 year history, Kids Oneida has demonstrated continuous service to the residents and communities which it serves; and

WHEREAS, The success of Kids Oneida is in direct correlation to the efforts of its staff, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and

an uncompromising standard of excellence in all endeavors on behalf of the organization and the community it serves; and
