WHEREAS, Before advancing to the national competition, the Fayetteville Girls Varsity Cross Country Team won the NYSPHSAA Class A Championship on November 11, 2017, at Wayne High School in Ontario Center, New York; this victory marked the Fayetteville-Manlius Girls Varsity Cross Country Team's 12th consecutive state title in the sport; and

WHEREAS, On December 2, 2017, the Fayetteville-Manlius Girls Varsity Cross Country Team dominated the 14th Annual Nike Cross Nationals at Glendoveer Golf Course in Portland, Oregon; this remarkable team captured first place, with an overall score of 89, defeating 21 other seven-person high school teams, which had qualified for the race via State competitions; and

WHEREAS, The Nike-sponsored course, with obstacles, rolling hills and tree-lined fairways, delivered a classic interpretation of the Pacific Northwest's storied running environments in front of an enthusiastic crowd; and

WHEREAS, The Nike Cross Nationals win was the Fayetteville-Manlius Girls Varsity Cross Country Team's 11th team title, further establishing the program as a national powerhouse; and
