HONORING Alfred H. Brand upon the occasion of his  
induction into The MOLES

WHEREAS, It is the sense of this Legislative Body that those who enhance the quality of life in their community and have shown a long and sustained commitment to the maintenance of high standards in their profession, certainly have earned the recognition and applause of all the citizens of this great Empire State; and

WHEREAS, Attendant to such concern, and in full accord with its long-standing traditions, this Legislative Body is justly proud to honor Alfred H. Brand upon the occasion of his induction into The MOLES; and

WHEREAS, The MOLES is an extremely prestigious national fraternal organization composed of leading individuals who have engaged in the construction of a tunnel, subway, sewer, foundation, marine, sub-aqueous or other heavy construction projects; and

WHEREAS, In 1968, Alfred H. Brand joined Mueser Rutledge Consulting Engineers, where he currently serves as a senior partner; and

WHEREAS, Throughout his illustrious 46-year career as a geotechnical engineer, Alfred H. Brand has been instrumental in the success of such major projects as the USTA Billie Jean King National Tennis Center in

Brand has been president and treasurer of the New York Chapter of the New York State Society of Professional Engineers; chairman of the Transportation Research Board, Committee on Tunnels and Underground Structures; and on the Executive Committee of Metropolitan Section ASCE, Foundations and Soil Mechanics Group; and
