WHEREAS, This Legislative Body is justly proud to commemorate the 50th Anniversary of Cellini Lodge No. 2206, Order Sons of Italy in America, to be celebrated at its Annual Scholarship/Charitable Benefit Dinner Dance on Friday, March 23, 2018, at the Chateau Briand, Westbury, New York; and

WHEREAS, This singular evening also features Cellini Lodge No. 2206, Order Sons of Italy's salute to its forebears, "Celebrazione Cinquantesimo Anniversario" recognizing the Lodge's 50 years of achievements on behalf of the Italian American community; and

WHEREAS, Through its Cellini Charitable Foundation, this venerable organization assists the Italian American community in a variety of ways, supporting many charities, scholarships, and Italian culture and language school programs; and

WHEREAS, As Cellini Lodge No. 2206, OSIA looks back on its sparkling history with just pride, it also recalls the founding of the Order Sons of Italy in America itself, as well as that of the Grand Lodge of New York; and

WHEREAS, Under the luminous leadership of President Mark
Ventimiglia, Cellini Lodge No. 2206 is part of OSIA's rich tradition of
service, advocacy, and cultural pride; and
