WHEREAS, Under her skilled leadership, the QB Resident Association was able to assist 60 residents in obtaining OSHA Training for Free, Film and Media, Career Development Workshops, plus collaborate with other community organizations to bring vital resources to the community; and

WHEREAS, April Simpson is an active member of several community and civil rights organizations, including the New York City Department of Youth and Community Development Neighborhood Advisory Board, the NAACP, and the Perkins Advisory Board at LaGuardia Community College; and

WHEREAS, April Simpson is the proud mother of three children and stepmother of six, and the loving wife of Daniel L. Taylor of almost 21 years, all of whom have showed her love and support and rejoice in her many achievements; and
