WHEREAS, On the morning of Wednesday, June 15, 2016, Ranger David Cornell responded to a 911 radio dispatch for a personal injury motorcycle crash at the intersection of Teelin Road and Oswego Road in the Town of Vienna; and

WHEREAS, The first on the scene, Ranger David Cornell found the motorcycle operator had suffered a severe leg injury with a deep laceration and major arterial bleeding; and

WHEREAS, Without hesitation, Ranger David Cornell removed his issued tourniquet and applied it the patient's injured leg to control the bleeding; he then assisted arriving EMTs with further patient care and the eventual transport to a helicopter airlift; and

WHEREAS, Ranger Cornell's quick medical response likely saved the patient's life; his calm and collected demeanor, decision making and actions were impeccable and the finest display of professionalism; and

WHEREAS, Ranger David Cornell should be regarded as a true hero; he has continually devoted himself to public service, demonstrating great courage and diligence in providing for the care and welfare of the citizens of this great Empire State; and

WHEREAS, Praised for maintaining his composure and his professional conduct, Ranger David Cornell demonstrated his true character and genuine compassion for the well-being of others; and

WHEREAS, Within every community of the State of New York there are certain individuals who, by virtue of their commitment and dedication, command the respect and admiration of their community for their

exemplary contributions and service on behalf of others; Ranger David Cornell is one such individual; and

WHEREAS, It is the custom of this Legislative Body that those dedicated public servants who unselfishly devote their lives to the preservation of order and the protection of others are worthy and due full praise for their commitment and noble endeavors; now, therefore, be it
