WHEREAS, Most of Kirsty Roefs' customers are from the Sidney, Bainbridge and Unadilla area, but some come from as far away as Oneonta and the Binghamton area; and

WHEREAS, In the future, Kirsty Roefs plans to expand House of Consignment's social media presence and to create an online store; and

WHEREAS, Kirsty Roefs will also continue her monthly philanthropic collection drives for worthy groups such as local homeless women, animal shelter pets, and cancer patients; and

WHEREAS, The success of House of Consignment is in direct correlation to the efforts of owner, Kirsty Roefs and her right hand man, Kevin Moore, whose involvement is, and always has been characterized by an impressive commitment, an unbridled enthusiasm and an uncompromising standard of excellence in all endeavors on behalf of the business and the community it serves; and
