WHEREAS, After graduation, Natasha Esteves began working at the Bedford Stuyvesant Community Partnership Program where she was able to use her personal and professional connections and relationships to help rebuild partnerships; and

WHEREAS, Throughout the years, with her vast experiences in the nonprofit sector, education system, mentally disabled, youth offenders, children services, foster care and community based organizations, Natasha Esteves has developed a passion for effective change in her community; and

WHEREAS, Natasha Esteves has flourished and grown into a truly amazing grassroots community organizer; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Natasha Esteves has displayed throughout her life; and
