As the legislature enters the final weeks, I am pushing for a number of local bills needed by our cities, towns and villages. **Last week, I passed my first bill as a State Senator. S.8349 transfers state land to the Town of Bedford to repurpose an existing wastewater treatment facility.** The bill had already passed in the Assembly and now goes to the Governor for his signature. **On Friday, I was proud to stand with Senator John Brooks (D-Long Island) in support of a new legislative proposal to provide property tax relief, particularly to high tax school districts, in light of the punitive Trump Tax plan's limit on deductions of property and income taxes.** Read more below about our efforts to address property tax burdens due to the impact of this federal bill in the section below.

**Locally, I was glad to attend the Inaugural Showcase of the Yonkers After School Academies on June 7th.
