WHEREAS, Father Michael A. Farano remained involved in the program frequently visiting the staff and children at the Center and lending whatever support was needed; and

WHEREAS, Over the past three decades, the Farano Center has undergone numerous transformations and today it serves children with mental health, behavioral or emotional needs who have been removed from their homes due to abuse or neglect; and

WHEREAS, The one thing that has not changed is Father Farano's commitment to the children who call the Farano Center "home"; his generosity and ongoing friendship have helped improve the quality of life for those in the Center's care; and

WHEREAS, This distinguished man of God has always given enlightenment, guidance and wisdom to the many entrusted to his care and has administered abundantly and unstintingly to the spiritual and corporal needs of all; and

WHEREAS, It is the sense of this Legislative Body that when a person of such noble aims and accomplishments is brought to our attention it is appropriate to publicly and jubilantly proclaim and commend that individual for the edification of others; now, therefore, be it
