Thompson and is the result of a collaboration between the DA's office and Kevin Livingston, President and Founder of the not-for-profit organization 100 Suits For 100 Men. The boutique will play a key role in assisting formerly incarcerated men and women returning to the job force by providing them with professional attire to wear during their search for employment.

As a long-time criminal justice reform advocate and believer of second chances, Senator Montgomery expressed her gratitude to DA Gonzalez for his leadership in helping previously incarcerated men and women make a smooth and successful re-entry into our community.

The Kenneth P. Thompson Boutique is located within the DA's Re-Entry Bureau and provides individuals enrolled in the DA's re-entry programs with business attire at no cost. The boutique is a direct reflection of Kenneth P. Thompson's legacy to restored trust between the community and the criminal justice system.

Mrs. Thompson reflected "my husband would be so proud to have his name associated with 100 Suits for 100 Men and would have been an avid supporter of Kevin Livingston and his amazing work. He would also have been pleased that Eric Gonzalez and the Brooklyn DA's office are continuing to keep his legacy alive by continuing to make strides in criminal justice reform."
