
I would like to wish you and your family the happiest of holidays!

## **Other Important Dates & Information**

**JAN 2, 2020 IS THE DEADLINE TO ENROLL IN THE INCOME VERIFICATION PROGRAM FOR ENHANCED STAR.**

\*New for 2019\* If you are applying or reapplying for the Enhanced STAR exemption, you must enroll in the [Income Verification Program \(IVP\)](#). You only need to enroll once, and you'll receive the exemption each year, as long as you're eligible. You will not need to reapply for the exemption or provide copies of your tax returns to your local assessor.

How to Enroll:

Nassau County homeowners: Submit Form [RP-425-IVP](#) along with the county's Enhanced STAR Property Tax Exemption Application (visit [Nassau County: Exemption Forms](#)). Submit both forms to the address on page 2 of the county form by January 2. For assistance, contact the **Nassau County Department of Assessment** at 516-571-1500.
