## Skoufis, Kaplan and 29 Majority Colleagues Urge Cuomo to Delay Sales Tax Collection to Aid Small Businesses

New York State Senator James Skoufis (D-39th District) and Senator Anna M. Kaplan (D-7th District), along with 29 colleagues from the Senate Democratic Majority Conference, sent a joint letter to Governor Cuomo urging him to delay without penalty the sales tax revenue collection due on Friday, March 20, 2020.

Senator James Skoufis said, "This is a critical time and we have an obligation to provide every

ounce of relief possible to small businesses that are deeply hurting. I urge the Governor to join the Conference in this push for a much-needed delay in tax collection and thank him for his leadership thus far.”

Dear Governor Cuomo:
