Dear Friends:

I hope you and your families have recovered from the effects of Tropical Storm Isaias. Though our power and phones may be back online, we will never forget the wholly inadequate response of our utility and telecommunications providers. Following the storm, my office and I spent hours every day filling a critical customer service role that utility and telecommunications providers had abdicated. We fielded complaints from some of our most

vulnerable residents, and we coordinated with these companies to ensure customers received proper attention. Lack of timely updates and systems for two-way communication between customers and these companies was just one of the major failures of the storm response.

Following the numerous failures of our utility and telecommunications providers, I fought for a public hearing to bring to light what went wrong and how things will be improved to ensure this pattern of failed storm responses does not continue year after year. The Senate and Assembly held a joint public hearing on Thursday, August 20th. [Click here](#) to watch the hearing. At the hearing, we heard from John Rhodes, Chair of the Public Service Commission, which oversees utilities and telecommunications providers, as well as the heads of Con Edison, NYSEG, Verizon, Altice (Optimum), and others. It is clear that major structural reforms must be implemented to protect the public and ensure improved performance. To that end, I will be announcing a package of bills this coming week to reform the NYS Public Service Commission, improve communication between providers and customers, and enhance accountability.

In addition to working to improve utility & telecommunication storm preparedness, this week I participated in a City & State webinar on Education in New York on Tuesday, August 18th; attended the Westchester County Police Reform & Reimagining Task Force Public Forum in Yonkers on the same day; and distributed food for seniors in New Rochelle.
