"Sailors should not follow you because they have to ... they should follow you because they were inspired to. I believe a true leader inspires and is inspired by the Sailors he or she leads."

"It was a tremendous honor to recognize Senior Chief Boatswain Mate and Police Officer Nolan for his dedication and service. Mr. Nolan has served our country and his community with honor and distinction, distinguishing himself in both military and civilian life. Kevin is currently preparing for a fifth deployment to protect and defend our country.

The sacrifices that Kevin and his family have made for us, while he is serving our country, are greatly appreciated. I was honored to be able to make today a special moment for Kevin and his wife, even though they could not be together, giving them the chance to see each other and celebrate this award together," said Senator Martinez.

The event was attended by a strong representation of the Suffolk County Police Department command staff, showing the profound respect and appreciation they too have for Police Officer Nolan's service. Commissioners Geraldine Hart and James Skopek were joined by Chief of Department Stuart Cameron and Chief of Patrol Robert Brown, as well as members of the Suffolk County Police Veterans Association for today's ceremony.
