New York State Homeowner Assistance Fund (HAF) Workshop - **Wednesday, Dec 15, 2021, 6:00 PM.** The [New York State Homeowner Assistance Fund \("NYS HAF"\)](#) is a federally-funded program dedicated to assisting homeowners who are at risk of default, foreclosure or displacement as result of a financial hardship caused by the COVID-19 pandemic. HAF will begin accepting applications in early January. Homeowners may qualify for up to \$50,000 in aid.

Join Senator Kevin Thomas and NYS Homes and Community Renewal for a virtual workshop where you can:

- Learn more about the program, including eligibility criteria and what types of assistance will be available;
- Enter your email to be notified when the application period opens; and
- Review a detailed guide about the NYS HAF application, including eligibility criteria and a list of documents you may need to provide when applying.

A representative will be present to answer any additional questions you have about the program or the application process.

### **FEMA & SBA Deadlines Extended**

The deadlines for **FEMA disaster assistance** and the **Small Business Administration's Physical Disaster Loan applications** have been extended to Jan. 4, 2022. **If you plan on filing for FEMA disaster assistance or an SBA loan, don't miss the Jan. 4 deadline to apply.**
