## Senator Rachel May Unveils Bill Package to Ensure Health of New York's Water Resources

| ISSUE: **CLEAN DRINKING WATER; ENVIRONMENTAL PROTECTION, CLEAN WATER; ENVIRONMENTAL PROTECTION**



Senator Rachel May (D-Onondaga, Madison, Oneida) introduces the “Public Water Justice Act” and “New York Open Water Data Act” to help protect New York State’s critical freshwater resources. Senator May will introduce a third bill in the coming days to reduce Perfluorooctane Sulfonate (PFOS) water contamination, which is commonly used in the industrial production of plastics.

- “Public Water Justice Act” [S9499](#) prohibits the bottling and sale of the state’s water without a license and requires anyone profiting off the sale of the state’s water to pay into a public water justice fund to protect New York’s watersheds.
- “New York Open Water Data Act” [S9520](#) brings together New York State’s water-related agencies to create, operate, and maintain a water data website, ensuring our freshwater resources are managed efficiently and will also give water users access to essential data to help inform decisions.
- “PFOS Discharge Disclosure Act” will require the DEC to create rules for testing and reporting the discharge of these chemicals into the surface waters of the state.
