Renee and her amazing team of volunteers have built three homes from the ground-up for our veterans and their families.

The Malta Veterans Appreciation Program, through Renee Farley’s steadfast leadership, built the Capt. USMC David T. Wallingford Malta Veterans Memorial Park and Brick Walkway at Town Hall, a serene place for residents to remember loved ones who served and the sacrifices that our veterans have given our country.

Renee and her incredible team of volunteers have also led food drives, helped veterans find medical equipment such as wheelchairs and hospital beds, winterized people’s homes, installed new porches and handicap accessible ramps, and dealt with plumbing emergencies. She and her team also drive veterans to medical appointments and grocery shopping.

Farley comes from a strong military family with her brother-in-law a colonel in the U.S. Army, another brother-in-law who served in the Army, a niece in the U.S. Air Force and three nephews currently in active duty in the military. One of Renee’s nephew’s, U.S. Army Staff
