School of Saratoga Springs, New York

WHEREAS, The Beagle School's summer camp is fortunate to extend its radius even further as families from around the country visit Saratoga for the summer and enroll their children in this well-respected camp known for the fun, educational and safe experience; and

WHEREAS, Under the able leadership of its Director, Jessica Todtenhagen, the Beagle School imparts the importance of community by building one within the school, while also aiming to be a valuable and contributing community member locally; and

WHEREAS, The school's curriculum includes exploration of the outdoors, dramatic arts, math and language skills, as well as enriching a child's education with life-skills, self-help skills and problem-solving skills in preparation for kindergarten and beyond; and
