WHEREAS, On many occasions, Logan Yates has acted with bravery and steady precision in dealing with the risk and drama of emergency situations; and

WHEREAS, In the performance of his duties, Logan Yates has demonstrated his character and his compassion for the welfare of others; he is a tremendous asset to his EMS Unit and a distinguished citizen of the State and Nation; and
