BILL NUMBER: S2722B

SPONSOR: GRIFFO

TITLE OF BILL: An act to amend the legislative law, in relation to limiting the amount of time any member of the legislature may serve as temporary president of the senate, speaker of the assembly, minority leader of the senate, minority leader of the assembly or chairman of a legislative committee

PURPOSE:

This bill limits the tenure of legislative leaders and committee chairs.

SUMMARY OF PROVISIONS:

Section 1 amends the Legislative Law by adding two new sections, 5-b and 5-c.

* 5-b limits the tenure of the temporary president, speaker and minority leaders to no more than eight (8) years.

* 5-c limits the tenure of the committee chair of a single committee to no more than eight (8) consecutive years.

Section 2 provides for an effective date.

JUSTIFICATION:

This bill is intended to keep New York State's leadership fresh and innovative, to allow an influx of new voices and perspectives in order to make better and broader the representation of the people of New York in the State's Legislature.
