## **COVID-19 STATE LEGISLATIVE & BUDGET UPDATE -**

In March, prior to the passage of the State budget, the Legislature addressed the coronavirus pandemic through the following measures:

- Enacting emergency paid sick leave for New Yorkers in quarantine due to exposure to COVID-19;
- Waiving the 7-day waiting period for unemployment insurance so workers whose employers closed due to the pandemic can get relief as quickly as possible;
- Providing for a \$40 million emergency relief package to help the State prepare for the challenges of fighting COVID-19;
- Granting temporary powers to the Governor to issue directives necessary to guide the State's response to the COVID-19 emergency.

While the COVID-19 pandemic disrupted the State budget process and 2020 Legislative Session, the Legislature passed a timely and balanced budget on April 2. This budget unfortunately includes cuts because of historic revenue shortfalls, but also these new funds to address the COVID-19 pandemic:

- **\$4 billion** in State emergency appropriations to directly address the COVID-19 crisis;
- **\$200 million** in additional support for the Child Care Development Block Grant to assist families affected by the public health emergency;
- **\$60 billion** in support for Unemployment Insurance, to provide a 13-week extension of benefits and an additional weekly benefit of up to \$1,100 a week, more than double the normal amount.

The budget also contains a number of my initiatives, including:

• New open space for Hudson River Park – With Community Board 4, I advocated for a provision in the budget that will finally force the NYPD's tow pound at Pier 76 to relocate, creating muchneeded open space;



I delivered face masks to frontline medical workers at Ryan Chelsea-Clinton Health Center, Bellevue Hospital & GMHC.

- **Ending gun violence** –The budget includes legislation based on The Safe Homes Act, my bill that requires law enforcement to take temporary custody of guns found at the scene of domestic violence incidents, which are rising during COVID-19 quarantines;
- Justice for domestic violence survivors The budget also contains my legislation requiring courts to consider the history of domestic violence when determining the equitable distribution of property during a divorce proceeding to protect the assets of survivors;
- \$10 million for immigrant legal services –
  With my advocacy, the budget includes
  \$10 million in new funding to provide immigrant New Yorkers with legal representation in deportation proceedings at a time when the Trump Administration has ramped up these actions;
- Access to free PEP for minors who are sexually assaulted – The budget also includes my legislation to ensure minors who are the victims of sexual assault are entitled to free post-exposure prophylaxis (PEP).

In addition, I passed these bills earlier in the legislative session:

- Adding two consumer representatives to the Public Health and Health Planning Council (S.7304), which is my and Assemblymember Richard Gottfried's bill in response to the closure of hospitals across Manhattan that has partly led to a lack of beds during the current COVID-19 health crisis;
- Legislation to require all rear passengers age eight and older wear seatbelts in taxis and livery vehicles (S.7134);

**Phasing out the use of PFAS chemicals in firefighting foam**, which can cause birth defects and certain cancers (S.7167).

I have many bills in response to the COVID-19 pandemic that were not addressed in the budget, including: S.8186, creating a \$1,000 tax credit for COVID-19 convalescent plasma donations; S.8182, authorizing pharmacists to administer COVID-19 vaccinations as soon as one has been approved for use by the FDA; and S.8195, allowing frontline medical personnel to take a tax deduction of up to \$5,000 for out-of-pocket transportation and PPE purchases they incur during the COVID-19 response efforts. I'm hopeful that the Senate will utilize our new ability to conduct legislative work remotely to pass these and many more legislative priorities.

## Fighting Evictions During the Pandemic \_\_\_\_\_

Thousands of tenants could face eviction this summer if the Governor's eviction moratorium ends without further tenant relief. To address this, I've announced the NYS Tenant Safe Harbor Act (S.8192), which would prevent landlords from seeking evictions for unpaid rent accruing from the beginning of the COVID-19 state of emergency until six months after it ends. I also co-sponsor legislation (S.8125-A) to cancel rent for 90 days for tenants who've lost their jobs due to COVID-19 and legislation with Assemblymember Harvey Epstein (S.8188) to permit tenants to terminate their leases early, without penalty, under emergency circumstances.

## **Budget Bright Spot: My Surrogacy Legislation Passes**

Surrogacy has been legal in 47 states, but not New York, where it was actually deemed a felony in certain circumstances. No longer. On April 2, the legislature passed our Child-Parent Security Act, which permits compensated surrogacy agreements. The legislation, which was part of the State Budget, enacts a Surrogates' Bill of Rights that provides the strongest protections in the nation for women acting as surrogates, ensuring they are entitled to make all healthcare decisions for themselves and receive independent legal counsel of their choosing, paid health and life insurance, and the right to counseling. The bill also contains new provisions to protect egg donors. I've fought to pass this legislation since I first arrived to the Senate in 2013, inspired by my family's own experience with surrogacy in California. Thanks to the work of hundreds of advocates who shared their heartfelt personal stories about surrogacy, LGBTQ people and individuals struggling with infertility can now plan to have families here in New York. This new law goes into effect on February 15, 2021.

## The Pandemic Shows We Must End the Gay Blood Ban



In the wake of the pandemic, I'm prouder than ever fighting for the expansion of vaccines.

Our nation is facing a tremendous national blood shortage, as thousands of blood drives have been cancelled due to concerns about coronavirus. In response, I sent a letter on March 24 urging the FDA to reverse its outdated and discriminatory ban on gay men donating blood, which could increase the overall blood supply by 4 percent, assisting more than 1.8 million Americans. After I sent my letter, the FDA loosened the ban, but I'll continue to advocate it be lifted entirely. This ban also applies to plasma donation, which is being sought from COVID-19 survivors for research and treatment by blood banks.

## Success! We Outlawed Flavored E-Cigarettes



Joining young advocates campaigning against flavored e-cigarettes in Albany. Vaping among young people is rising at an alarming rate in our state, threatening to hook a new generation on nicotine. According to NYS Department of Health, nearly 40 percent of 12th grade students and 27 percent of all high school students in New York are now using e-cigarettes, largely because of flavored e-liquids. Therefore, I'm glad that this year's State Budget includes my legislation (S.428-B/A.47-A) with Assemblymember Linda B. Rosenthal to impose a statewide ban on flavored e-cigarettes, including menthol. Our new law is even more important since the FDA has warned that vaping increases susceptibility to respiratory illnesses like COVID-19.

## **Cracking Down on Price Gougers During the Pandemic**

I'm sure you've noticed dramatically higher prices on everyday consumer medical supplies, such as face masks and hand sanitizers. This price gouging hurts seniors and lower-income people the most. I've introduced legislation (S.8189) that will allow the Attorney General to go after price gougers of New York State and local governments as they seek to procure essential medical supplies and equipment. I've also introduced legislation (S.7932) similar to existing laws in California and New Jersey allowing the Attorney General to penalize any retailer, distributor or manufacturer who sells consumer medical supplies for an "unconscionable excessive price" that is 10% or more higher before a public emergency.
