#### **DEFENDING OUR NEIGHBORHOODS**

Housing is the number one issue that constituents bring to my office. We have to make sure that the law is protecting tenants not landlords, and that landlords aren't incentivized to put profits over people. To ensure that this is the case, I've sponsored and co-sponsored pro-tenant legislation needed to protect you from predatory landlords and developers. These bills are part of a comprehensive strategy to combat gentrification and keep tenants in their homes. This includes a bill to keep rent controlled apartments affordable, a bill to end vacancy decontrol, and a bill to keep landlords from raising preferential rents dramatically.

In addition to fighting for you with legislation in Albany, we've continued to meet with tenant leaders across the district to make sure concerns are being answered. In November, we will be focusing on HDFCs and NYCHA, and hosting events on both topics. We have also participated in an event to inform the community about housing succession rights. With the help of other elected officials, community activists, and the wonderful residents and staff at Morningside Retirement and Health Services, we restored the state funding. This will ensure another year of excellent programming that will enrich the welfare of the neighborhood at large.
