

## ADDITIONAL NY STATE EDUCATIONAL BENEFITS

In addition to the programs mentioned, New York State offers educational benefits for its veterans and their families. Most of these programs are administered by the New York State Higher Education Services Corporation (HESC).

### Veterans Tuition Awards

The Veterans Tuition Awards are for full-time study and part-time study for eligible veterans matriculated in New York State.

- For full-time study, a recipient shall receive an award of up to the full cost of undergraduate tuition for New York State residents at the State University of New York, or actual tuition charged, whichever is less.
- For part-time study, awards will be prorated by credit hour.

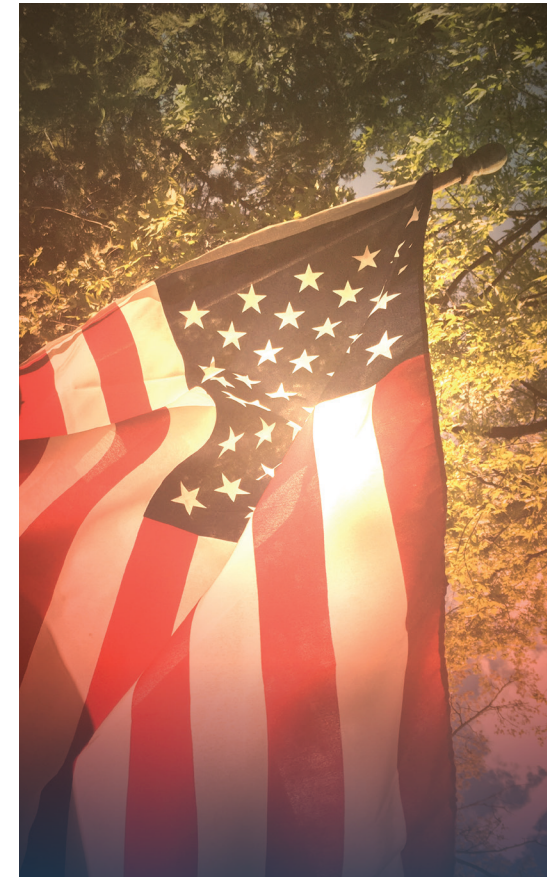

## RECENTLY DISCHARGED VETERANS

If you are a veteran who has been recently discharged from service, there are several important measures you need to follow to ensure that you receive all of the benefits that you are entitled to. First, you need to secure your discharge certificate - DD Form 214. If you need help obtaining your DD Form 214, contact the New York State Division of Veterans' Affairs at 1-888-VETSUNYS (1-888-838-7697) or by email at

DVAInfo@veterans.ny.gov. You also need to:

- Enroll in VA health care within your first 12 months from separation; and
- Visit your nearest New York State Veterans Counselor or County Veteran Service Agency.

It is helpful to bring the following documentation when you visit: Form DD214, medical records, bank account information and dependent information.

## VETERAN EMPLOYMENT

The New York State Division of Veterans' Affairs is proud to provide veterans and their eligible spouses with One-Stop Career Centers. These centers will assist you and your eligible spouse in:

- Career counseling;
- Skills assessment;
- Job search assistance;
- Resume preparation;
- Information on Civil Service positions; and
- Referrals to other agencies that provide services to veterans.

## VETERAN HEALTH BENEFITS

Veterans' health benefits are administered by the United States Department of Veterans Affairs (VA). While the VA provides a medical benefits package to all enrolled veterans, you must apply to receive these benefits. To be sure you qualify for these benefits, you need to fill out form 10-10 EZR, which is provided online for your convenience at [www.va.gov/healthbenefits/](http://www.va.gov/healthbenefits/). ## HELPING OUR HEROES: ASSISTING SERVICE-DISABLED VETS

The Service-Disabled Veteran-Owned Business Act creates a six percent contract preference "set-aside" for service-connected disabled veteran-owned businesses. This helps New York State's approximately more than 100,000 service-disabled veterans to pursue successful new business ventures and be better able to compete for millions of dollars in New York State contracts.

- Eligible businesses can get certified through New York State's Office of General Services (OGS). Once certified, disabled-veteran operated companies can bid on state contracts.

This important law provides an enormous boost to our service disabled veterans, opening the door to major new business opportunities.

## CONFIDENTIAL VETERANS CRISIS LINE

The crisis line provides veterans free, confidential support 24/7/365, even if they are not registered with the VA or enrolled in VA healthcare.

Toll-free and confidential, the Veterans Crisis Line connects veterans and their families and friends with professional, caring Department of Veterans Affairs (VA) responders, many of whom are veterans themselves. The responders provide support for an array of issues, such as chronic pain, relationship problems, anxiety and depression, sleeplessness and even homelessness.

## "HIRE-A-VET" TAX CREDIT

When New York's servicemen and women return home, they should be welcomed with the promise of economic opportunity. The Hire-A-Vet Credit encourages the employment of qualified veterans. Businesses may earn up to \$5,000 for hiring a qualified veteran, and up to \$15,000 for hiring one who is disabled. ## POST-9/11 GI BILL AND OTHER EDUCATIONAL PROGRAMS

- Montgomery GI Bill - Active Duty (MGIB-AD)
- Montgomery GI Bill - Selected Reserve (MGIB-SR)
- Reserve Educational Assistance Program (REAP)
- Veterans Educational Assistance Program (VEAP)
- Educational Assistance Test Program (Section 901)
- Survivors and Dependents Educational Assistance Program (DEA)
- National Call to Service Program
- Veterans Retraining Assistance Program
- Vocational Rehabilitation Program and Counseling
- Free education and counseling services are available to service members and veterans.
