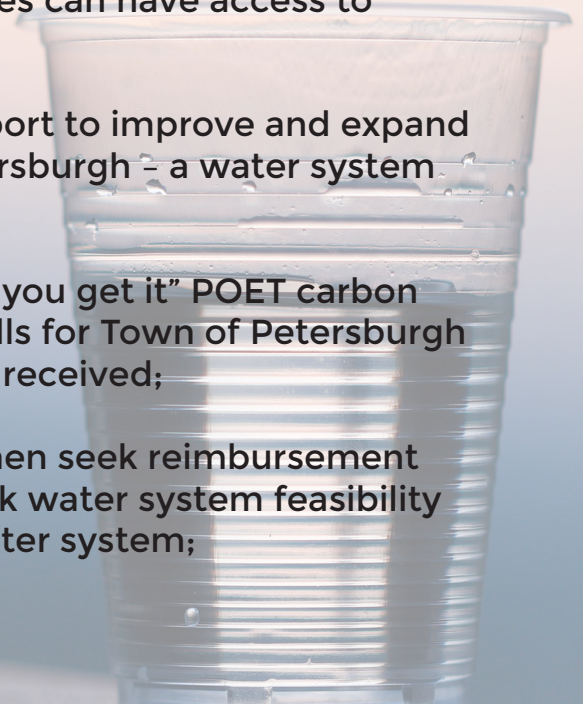

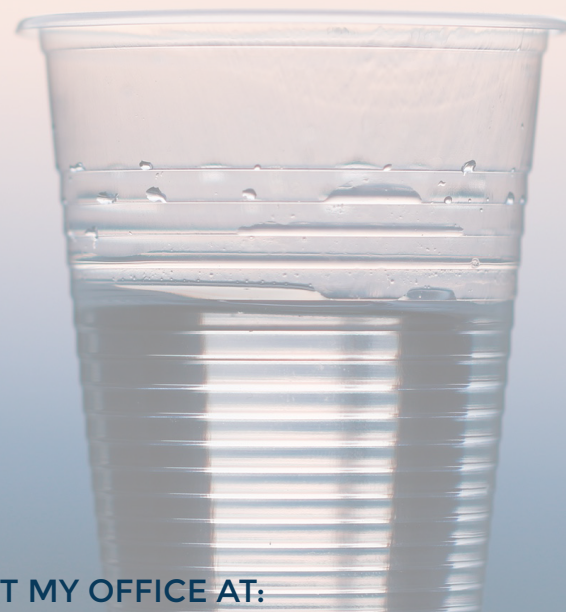
DELIVERING HELP AND REAL RESULTS FOR HOOSICK FALLS & PETERSBURGH

From the first day she was notified of the PFOA public health crisis in Hoosick Falls and Petersburgh, Senator Kathy Marchione's sole focus has been the health, safety and well-being of areas families and delivering real results to help the communities.

- The following are some of the positive action steps that Senator Kathy Marchione has already taken, or are in the process of being taken, to help families in Hoosick Falls and Petersburgh in addressing the PFOA public health crisis:
- Issuance of an emergency state regulation to classify PFOA as a hazardous substance;
- Classifying Saint-Gobain Facility and Taconic Plastics as state Superfund sites to unlock resources to address contamination;
- Filtration systems at the Berlin Central School District and the Hoosick Falls Central School District;
- Ensuring blood testing and establishing a state hotline - **1-800-801-8092** - to provide additional information so families can have access to regular updates;
- Submission of a preliminary engineering report to improve and expand the existing municipal water system in Petersburgh - a water system that will cost approximately \$8.5 million;
- Continuation of the policy of "if you want it, you get it" POET carbon filtration systems for individual personal wells for Town of Petersburgh residents, just as Town of Hoosick residents received;
- An agreement that the state will pay (and then seek reimbursement from Saint-Gobain) for the costs of a Hoosick water system feasibility study to expand Hoosick Falls' municipal water system;



- An agreement for funding to hire an Environmental Engineer for the Town of Hoosick so the community can be assured of an independent analysis;
- An agreement that the state will pay for six months of water for Town of Petersburg residents, which is the same as received by Hoosick Falls residents; an agreement that the state will work with company officials to help provide for relief for Town of Petersburg employees regarding the distribution of bottled water;
- Advocated for future bio-monitoring and blood testing for the Village of Hoosick Falls, the Town of Hoosick and Town of Petersburg residents;
- Local on-site blood testing for Petersburg residents on Saturday, July 23, at the Petersburg Community Center, from 9 AM to 2 PM;
- Continuation of an independent health cancer study conducted by Mt. Sinai (Mt. Sinai physicians will host information sessions on PFOA exposure for Petersburg on Friday, July 29, from 6 to 9 PM at the Veterans Memorial Community Center, 71 Main Street and for Hoosick Falls on Saturday, July 30, from 11 AM to 2 PM, at the HAYC3 Armory, 80 Church Street; for more information call 1-866-265-6201).
