



COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Racing, Gaming & Wagering has legislative oversight responsibilities for issues concerning New York State Horse Racing subsidies, Gaming facilities, as well as Problem Gaming concerns.

The Committee also led the charge in authorizing the state to provide a \$455 million capital loan to the New York Racing Association for re-developing the Belmont Race Park. The legislative authorization mandated the property located at the Aqueduct Racetrack be relinquished back to the state upon completion of the new Belmont Park.

During the 2023 Legislative Session, 39 bills were referred to the Committee for its review. Of these bills, 13 were reported from the Committee, 10 were passed by the Senate, and 4 passed in both houses. This work was conducted through a series of 3 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2022:

- S.497 (Stec) Passed Senate, this bill authorizes organizations to receive a license to hold a game of chance on Easter Sunday and Christmas Day.
- S.1156 (Skoufis) Passed Senate, this bill permits employees of authorized organizations to operate games of chance.
- S.4738 (Kennedy) Passed Senate, this bill permits participation in games of bingo by minors who are accompanied by an adult.
- S.5549 (Kennedy) Passed Senate, this bill will prohibit regional off-track betting corporations from
 providing items of value exceeding fifteen dollars to any board member, officer, or employee of the
 corporation, any contractor, subcontractor, consultant, or other agent of the corporation or any spouse,
 child, sibling, or parent of such persons; adds reporting requirements for regional off-track betting
 corporations.
- S.5550 (Kennedy) Passed Senate, this bill prohibits off-track betting corporation vehicles from being used as take-home vehicles by board members, officers, employees, contractors, subcontractors, consultants, or agents of such corporation or by certain family members of such individuals; provides an exception therefor.

TWO HOUSE BILLS

In 2023, 4 of the 11 bills referred to the Standing Committee on Racing, Gaming, & Wagering passed both houses of the Legislature. Of these bills, the Governor has signed 4 and vetoed none.
