COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Commerce, Economic Development, and Small Business has legislative oversight responsibilities for issues concerning small and large businesses arising under the Economic Development Law and the State Administrative Procedures Act. The Committee also handles issues arising under specific provisions of five other laws: Alcoholic Beverage Control Law provisions relating to beer and cider as well as liquor licensing and fees; Banking Law provisions concerning the New York business development corporation and small business investment companies; an Executive Law provision providing for the Office of Business Permits; Public Authorities Law provision pertaining to NY Job Development Authority, Long Island Job Development Authority, and Public Health Law's NYS Small Business Health Insurance Partnership Program

During the 2022 Legislative Session, eighty-six bills were referred to the Committee for its review. Of these bills, twenty-nine were reported from the Committee. Eighteen were passed by the Senate, ten passed in both houses, and five of these bills have been chaptered to date. This work was conducted through a series of five committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee co-hosted a Joint Public Hearing with the Finance and Investigations and Government Operations Committees examining the effectiveness of business subsidies and tax incentives in meeting New York State's economic development goals in order to identify any legislative and policy reforms.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2022:

- **S. 25-C KAPLAN** Requires the Empire State Development Corporation, in consultation with SUNY, CUNY, and the Commission on Independent Colleges and Universities to conduct a study on the economic impact of the establishment of kitchen incubators.
- S. 28-A KAPLAN, COONEY, HELMING, HINCHEY, JACKSON, JORDAN, MARTUCCI, RATH, STEC, TEDISCO - Requires those state agencies that regulate small businesses to maintain a section on their websites where small businesses can get easy access to the information they need, provide feedback to the agency and seek assistance in complying with regulations.
- S. 3098-D KAPLAN, ADDABBO, GAUGHRAN, HINCHEY, MARTUCCI Establishes the New York state advisory council on coronavirus economic recovery and workforce development which will work to promote economic development and collaboration opportunities.
- S. 3142 GOUNARDES, HELMING, HINCHEY, JORDAN, MARTUCCI Provides assistance to small businesses in the procurement and purchase of personal protective equipment for employees; directs bulk purchasing of PPE by the division for small business; provides a tax credit for the cost of such PPE to small business employers.
- S. 3313 BAILEY, ADDABBO, COMRIE, GOUNARDES, HOYLMAN, MAY, PARKER, PERSAUD, RAMOS, SANDERS Relates to the establishment of a state university-based center for employee ownership.
- S. 8325 KAPLAN, SERINO Establishes a matching grant program for small businesses receiving phase one or phase two funding under the federal small business innovation research program or the small business technology transfer program to promote commercialization and cover certain expenses.
- S. 8363 KAPLAN Provides for the creation of an online, searchable database to catalogue workforce development programs and funding available in the state.
- S. 8596 KRUEGER, KAPLAN, CLEARE, HARCKHAM, RAMOS, SALAZAR Establishes the Supply Chain Transparency Assistance Program to encourage the shifting of the state's economy toward more ethical and sustainable supply chains.
- **S. 8741 HINCHEY**, **MAY** Enacts the New York textile act to accelerate the growth of the animal and plant fiber growing, processing, and textile manufacturing industry in New York.
- S. 9467 COONEY, MANNION, BRESLIN Allows for eligibility of green CHIPS projects in the Excelsior tax credit program.

TWO HOUSE BILLS

In 2022, twelve of the eighty-six bills referred to the Standing Committee on Commerce, Economic Development and Small Business passed both houses of the Legislature. Of these bills, the Governor has signed ten and vetoed none. Currently two bills are pending Executive action.
