

COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Cultural Affairs, Tourism, Parks and Recreation has legislative oversight responsibilities for issues concerning the State system of parks and historic sites, arts development, tourism initiatives, and advancing recreational opportunity for New Yorkers.

During the 2019 Legislative Session, fifty-six bills were referred to the Committee for its review. Of these bills, sixteen were reported from the Committee, twenty were passed by the Senate, and eight passed in both houses. This work was conducted through a series of three committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

TWO HOUSE BILLS

In 2019, eight of the fifty-six bills referred to the Standing Committee on Cultural Affairs, Tourism, Parks and Recreation passed both houses of the Legislature. Of these bills, the Governor has signed four and vetoed four.
