COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Finance has legislative oversight responsibilities for issues concerning Budget, Fiscal Review, Resolutions and Nominations.

During the 2021 Legislative Session, 677 bills were referred or dual referent to the Committee for its review. Of these bills, 137 were reported from the Committee, 221 were passed by the Senate, and 134 passed in both houses. This work was conducted through a series of 16 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held 14 hearings and/or roundtable meetings. Topics of these hearings and/or roundtables included:
