COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Codes has legislative oversight responsibilities for issues concerning the Penal Law, the Criminal Procedure Law, the Civil Rights Law, and certain parts of the Executive Law.

During the 2024 Legislative Session, over 600 bills were referred to the committee for its review. Of these bills, 95 were reported from the committee. Sixty-seven were passed by the Senate. Nine of these bills also passed the Assembly. This work was conducted through a series of 11 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

The committee did not hold any specific public hearings or roundtable meetings during this session.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2024:

- **S7392A** (Myrie) Signed chapter 123 of 2024. This bill relates to the dangers to safety and health and the creation of a public nuisance caused by the sale, manufacturing, distribution, importing, and marketing of firearms.
- **S2922** (Cleare) Signed chapter 503 of 2024. This bill deems a person who engages in sexual conduct during the period of their probation with his or her supervising probation officer as being incapable of consent.
- **\$5302** (Fernandez) Signed chapter 545 of 2024. This bill includes removal or threat of removal of religious clothing as aggravated harassment in the second degree.
- **\$8744** (Krueger) Signed chapter 462 of 2024. This bill repeals the crime of adultery.
- **S7739B** (Scarcella-Spanton) Signed chapter 543 of 2024. This bill requires wireless communication method service providers disable services to stolen wireless phones.
- **S6649** (Gianaris) Signed chapter 428 of 2024. This bill relates to warnings to be posted and provided by firearms dealers.
- **S6798A** (Oberacker) Signed chapter 232 of 2024. This bill permits certain defendants in a criminal action in Delaware, Otsego or Schoharie county to appear electronically, with the approval of the court.
- **S7365B** (Hoylman-Sigal) Signed chapter 429 of 2024. This bill relates to pistol converters.
- **S8687** (Bailey) Veto 70 of 2024. This bill requires accurate interpretation of statements made by deponents with limited English proficiency in accusatory instruments and supporting depositions.
