#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Civil Service and Pensions has legislative oversight responsibilities for issues concerning the civil service and retirement systems in our state.

During the 2024 Legislative Session, 292 bills were referred to the Committee for its review. Of these bills, 63 were reported from the Committee. Eighteen bills were passed by both houses and seven were passed by the Senate only. The Governor has signed twelve bills into law and vetoed six bills. This work was conducted through a series of seven committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.
