I am pleased to transmit the Annual Report of the Senate's Standing Committee on Commerce, Economic Development and Small Business for the 2024 Legislative Session. As Chair, I am proud to continue to lead our efforts to address important matters under my committee's jurisdiction, including issues concerning small and large businesses arising under the Economic Development Law and the State Administrative Procedures Act. COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Commerce, Economic Development and Small Business has legislative oversight responsibilities for issues concerning concerning small and large businesses arising under the Economic Development Law and the State Administrative Procedures Act. The Committee also handles issues arising under specific provisions of five other laws: Alcoholic Beverage Control Law provisions relating to beer and cider as well as liquor licensing and fees; Banking Law provisions concerning the New York business development corporation and small business investment companies; an Executive Law provision providing for the Office of Business Permits; Public Authorities Law provision pertaining to NY Job Development Authority, Long Island Job Development Authority, and Public Health Law's NYS Small Business Health Insurance Partnership Program.

During the 2024 Legislative Session, eighty bills were referred to the Committee for its review. Of these bills, seventeen were reported from the Committee. Fourteen were passed by the Senate, and nine passed in both houses. This work was conducted through a series of three committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held a joint public hearing with the Senate Standing Committees on Finance, Investigations and Government Operations, and Budget and Revenue analyzing the independent report authorized by Tax Law § 180.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2024:

- S.962 BAILEY, ADDABBO, COMRIE, GOUNARDES, HOYLMAN-SIGAL, MAY, PARKER, PERSAUD, RAMOS, SANDERS - Relates to the establishment of a state university-based center for employee ownership that provides education and outreach to business owners regarding employee ownership.
- S.1979 CLEARE, BORRELLO, JACKSON, WEBB Relates to a study on the economic impact of the establishment of kitchen incubators.
- **S.5354 RYAN** Relates to financial assistance to small businesses for the purpose of pollution prevention, control and compliance.
- S.5357 WEBB Relates to allowing bed and breakfasts to sell cider, liquor, beer and wine.
- S.8109 MANNION, CHU, BORRELLO, WEBB Requires the division for small-business to publish a small business compliance guide.
- S.9268 RYAN, MURRAY Creates an I Love NY Historic Small Business niche brand.
- **S.9280 RYAN, ROLISON -** Establishes the small business energy conservation ombudsman program.

PUBLIC HEARINGS, ROUNDTABLES & NOMINATIONS

On November 20, 2024, the Senate Standing Committee on Commerce, Economic Development and Small Business held a joint public hearing with the Senate Standing Committees on Finance, Investigations and Government Operations, and Budget and Revenue. The subject of the hearing was the report generated and distributed in December of 2023 pursuant to Tax Law § 180. The report sought to assess the utilization rate, job creation, and return on investment for each economic incentive program in New York State.

Witnesses were split into five panels, and included Empire State Development, PFM Consulting, good government groups, and business groups. Over the course of the hearing, members from each of the committees asked witnesses questions intended to clarify the analysis in the report, reach consensus about the effectiveness of various incentives, and determine ways to make economic development more effective.
