COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Cultural Affairs, Tourism, Parks and Recreation has legislative oversight responsibilities for issues concerning the State system of parks and historic sites, arts development, tourism initiatives, and advancing recreational opportunity for New Yorkers.

During the 2024 Legislative Session, Sixty-five bills were referred to the Committee for its review. Of these bills, twenty-two were reported from the Committee. Fifteen were passed by the Senate, and thirteen passed in both houses. This work was conducted through a series of three committee meetings. A list of all bills that were reported from the committee is provided at the end of this report. The Committee also advanced nineteen nominations to positions on the New York State Council on the Arts, the State Board for Historic Preservation, as well as numerous regional commissions for parks and historic preservation.

In addition to its regular meetings, the Committee held a joint Arts Day forum in February of 2024 with the Assembly Standing Committee on Tourism, Parks, Arts and Sports Development that examined testimony and perspectives of various arts disciplines and practitioners from across the state on the role that arts and culture plays in community development, diversity and inclusion, and education.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2024:

- **S253A**(SERRANO) Pending Governor approval. This bill requires New York State to develop criteria and guidelines to establish State designated arts and cultural districts.
- **S722** (SERRANO) Chapter 340 of 2024. This bill authorizes the Office of Parks, Recreation and Historic Preservation to establish a resident curator program for the rehabilitation of certain state park buildings that have fallen into disuse.
- **S5423** (MARTINEZ) Chapter 60 of 2024. This bill prohibits the mandated use of credit cards at State Park facilities.
- **S5714A** (CLEARE) Passed Senate. This bill requires New York State arts and cultural initiatives to increase consideration for diversity, equity and inclusion, racial and social justice, and cultural preservation within various programmatic criteria.
- **S7296A** (HINCHEY) Pending Governor approval. This bill requires the New York State Council on the Arts to include members from each of the ten regions of the state to further ensure regional representation in New York State's arts programming.
- **S9241** (SERRANO/ORTT) Chapter 119 of 2024. This bill provides OPRHP with the authority to inspect and regulate vessel operations on certain non-navigable underground waterways.

PUBLIC HEARINGS, ROUNDTABLES & NOMINATIONS

Arts Day Forum- The Senate and Assembly held a joint Arts Day Forum in February of 2024, where members from each house's respective committee on arts and cultural development heard testimony from arts advocates, entrepreneurs and educators, discussing the many roles that arts and culture play in our communities and how New York can continue supporting these endeavors.
