#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Elections has legislative oversight responsibilities for issues concerning election security, voter registration, and the State Board of Elections practices and procedures.

During the 2024 Legislative Session, 226 bills were referred to the Committee for its review. Of these bills, 48 were reported from the Committee. 40 were passed by the Senate, and 7 passed in both houses. This work was conducted through a series of four committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

#### COMMITTEE HIGHLIGHTS

In 2024, the following key package of bills was acted on by the committee to reform and improve election administration in New York:

- S.610 (Hoylman-Sigal) Chapter 500 of 2024. To allow local Boards of Elections to establish absentee ballot drop-off locations to provide voters with a convenient alternative option to submit their absentee ballots.
- S.612D (Mayer) Chapter 639 of 2024. To end the actual and perceived conflicts of interests of board of elections employees caused by outside income related to the administration of elections and supervision of elections in which they are candidates.
- S.6199B (Myrie) Chapter 655 of 2024. To prevent bad actors from gaming the system concerning candidate designation for certain county committees.
- S.136 (Krueger) Passed Senate. To increase the pay of election inspectors and coordinators.
- S.371 (Gianaris) Passed Senate. Banning political spending by foreigninfluenced business entities in New York's state and local elections.
- S.617 (Myrie) Passed Senate. The purpose of this bill is to ensure consistent training of election commissioners by the New York State Board of Elections (NYSBOE).
- S.657A (Myrie) Passed Senate / In the Budget. To create a New York State Voting and Elections Database in the State Board of Elections and an Academic Center which will compile New York's election data and administer it for research and to provide election operation assistance to political subdivisions as well as the public.
- S.4433 (Fernandez) Passed Senate. To permit boards of elections to hire college and university students as elections inspectors without compliance with certain requirements.
- S.4733 (Krueger) Passed Senate. To ensure that campaigns that are paying social media influencers to make posts on behalf of a campaign disclose such information.
- S.6638B (Parker) Reported from Committee. An act to amend the election law and the legislative law, in relation to the use and disclosure of synthetic media

#### **TWO HOUSE BILLS**

In 2024, 7 of the 226 bills referred to the Standing Committee on Elections passed both houses of the Legislature. Of these bills, the Governor has signed 5 and vetoed none. In addition, 2 bills remain to be acted on by the Governor.
