## COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Energy and Telecommunications has legislative oversight responsibilities for all issues concerning but not limited to the production, delivering, building, defining and elevation of energy and telecommunications this includes the assistance for residents providing information and advising as needed major government bodies inside the jurisdiction of this standing committee. Improving workforce readiness and aiding in the effort to meet the state and federal government short- and long-term energy goals.

During the Legislative session, the committee had a reported 108 bills referred to the Committee for its review. Of these bills seventy-seven bills were moved out of the committee. Fifty were passed by the Senate. Fifteen passed in both houses. This work was conducted through a series of seven committee meetings. A list of all the bills that were reported to the committee is provided at the end of this report.

In addition to its regular meetings, the Committee held several joint hearings with Finance to address appointees from the Governor's office and work on any joint issues that need resolution with joint committee assistance.

## **COMMITTEE HIGHLIGHTS**

The following key bills were acted on by the committee in 2024:

- S489A (Comrie)- Requires NYSERDA to develop a comprehensive electric vehicle fast charging station implementation plan.
- S8841 (Parker)- Requires the New York state energy research and development authority to develop recommendations regarding the establishment of microgrids.
- S9188 (Comrie)- Relates to information required to be published prior to a major rate change by a public gas or electric utility.
- S8372 (Parker)- Relates to utility intervenor reimbursement.
- S8626A (Mannion)- MANNION -- Relates to call centers for gas and electric corporations.
- S8575 (Ryan)- Enacts the "home utility weatherization jobs act."
- S8402 (Parker)- Enacts the "go green schools act" to assist school districts in converting to renewable energy systems.
