I am pleased to transmit the Annual Report of the Senate's Standing Committee on Environmental Conservation for the 2024 Legislative Session. As Chair, I am proud to continue to lead our efforts to address important matters under my committee's jurisdiction.

During the 2024 session, this committee met 8 times and reported 106 bills. Of the 33 bills that passed both houses, 22 have been signed by the Governor, and 7 have been vetoed.

In my role as Chair, I hosted a roundtable in October, bringing environmental experts and advocates together to share their priorities for the coming legislative session in the wake of the United States Supreme Court overturning the ruling of Chevron v. Natural Resources Defense Council. Additionally, in September I traveled to Long Island in order to attend a roundtable hosted by local environmental leaders, in order to gain perspective on and discuss the unique issues impacting Long Island's ecosystems.

I thank my colleagues who served on the Committee for their efforts and support of the work that was done in the committee this year, and I thank you for the continued support from the Majority Conference in the committee's operations.

COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Environmental Conservation has legislative oversight responsibilities for issues concerning the environment and environmental conservation law.

During the 2024 Legislative Session, 285 bills were referred to the Committee for its review. Of these bills, 106 were reported from the Committee. 82 were passed by the Senate, and 33 passed in both houses. This work was conducted through a series of 8 committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2024:

- S897C (Hoylman-Sigal): Reported to Senate Finance. This bill establishes the climate corporate data accountability act, requiring US-based businesses with annual revenues greater than one billion dollars operating within the state to annually disclose scope 1, scope 2 and scope 3 emissions.
- S1292A (Parker): Passed Senate. This bill establishes the Clean Fuel Standard of 2024. The legislation is intended to reduce greenhouse gas intensity from the on-road transportation sector, with further reductions to be implemented based upon advances in technology.
- S2127C (Gianaris): Passed Senate. This bill establishes an indirect source rule to regulate air quality and emissions from vehicles associated with the operations of certain heavy distribution warehouse facilities. The rapid proliferation of vehicle-intensive e-commerce suggests that an indirect source review for warehouses and other indirect sources is necessary to improve air quality and protect public health.
- S2129 (Krueger): Passed Both Houses. This bill establishes the climate change adaptation cost recovery
 program to require companies that have contributed significantly to the buildup of climate-warming
 greenhouse gases in the atmosphere to bear a share of the costs of needed infrastructure investments
 to adapt to climate change.
- S4198B (Comrie): Veto 56 of 2024. This bill enacts the "New York wildlife crossing act"; directing the Department of Transportation and the New York State Thruway Authority to identify sites along all highways, thruways and parkways in the state where wildlife crossings are most needed.
- S4246D (Harckham): Passed Senate. This bill enacts the "packaging reduction and recycling infrastructure act" to require companies selling, offering for sale, or distributing packaging materials and products to register with a packaging reduction organization to develop a packaging reduction and recycling plan.
- S4265B (Webb): Committed to Rules. Enacts the "beauty justice act"; provides for the regulation of ingredients in personal care products and cosmetics; prohibits the sale of personal care products and cosmetic products containing certain restricted products.
- S5331A (Harckham): Chapter 552 of 2024. This bill expands the food donation and food scraps recycling program by scaling down the annual average tonnage requirement every two years until 2028.
- S5648F (Hoylman-Sigal): Passed Senate. This bill prohibits the sale of certain products that contain regulated perfluoroalkyl and polyfluoroalkyl substances.
- S5868B (Harckham): Passed Both Houses. This bill imposes prevailing wage requirements under private contract to be eligible for the tangible property tax credit associated with brownfield redevelopment
- S7736B (Webb): Passed Senate. This bill would bolster existing protections by explicitly requiring an environmental impact statement for mining under a lake, as well as an updated reclamation plan along with appropriate financial security to ensure the communities relying on Cayuga Lake and its watershed are protected from potential harm.
- S8356A (May): Passed Senate. This bill enacts the "harmful algal bloom monitoring and prevention act."
 This bill would charge the DEC with establishing a coordinated system of HABs monitoring, evaluation, prevention and mitigation.
- S8357 (Webb): Delivered to Governor. This bill prohibits well permits from being issued to an applicant that uses carbon dioxide to complete or recomplete natural gas or oil resources. Consistent with New York's ban on hydraulic fracturing, this bill would ban the use of carbon dioxide in gas or oil extraction.
- S8703A (Hinchey): Delivered to Governor. This bill requires the owner or operator of a vessel to establish and maintain with the department evidence of financial responsibility sufficient to meet the amount of liability.
