#### COMMITTEE JURISDICTION AND OVERVIEW

The New York State Senate Standing Committee on Cities 1 has legislative oversight responsibilities for issues concerning the City of New York.

During the 2024 Legislative Session, 140 bills were referred to the Committee for its review. Of these bills, 50 were reported from the Committee. Five were passed by the Senate, and fifteen passed in both houses. This work was conducted through a series of seven committee meetings. A list of all bills that were reported from the committee is provided at the end of this report.

#### COMMITTEE HIGHLIGHTS

The following key bills were acted on by the committee in 2024:

- **S509B (Thomas, Jackson, Webb)** Requires restaurants that offer online delivery services to post on their website or mobile application a hyperlink to view recent sanitary inspection grades **Significant Act: 11/25/24 Chaptered 540**
- **S7383A (Sepúlveda, Parker)** Requires public notice and comment for any contract for goods, services or construction to be awarded by other than competitive sealed bidding or competitive sealed bids from prequalified vendors in excess of a threshold established by the procurement policy board by rule; provides for the repeal of such provisions upon the expiration thereof.

- **S8529 (Jackson)** Provides for a line of duty presumption for disabilities of deputy sheriffs in a city with a population of one million or more. **Significant Act: 12/13/24 Veto #85**

The Committee also had several productive meetings in the Spring and Fall of 2024, with the Commissioner of the New York City Department of Finance to work towards instituting a major reform of New York City's property tax system and

introducing legislation in that regard in 2025.

## **TWO HOUSE BILLS**

In 2024, fifteen of the 140 bills referred to the Standing Committee on Cities 1 passed both houses of the Legislature. Of these bills, the Governor has signed thirteen and vetoed two.
