However, the GLOW WDB has run into many bureaucratic roadblocks that hinder its ability to serve the people of the GLOW region. The WDB has respectfully communicated its concerns to you and to other lawmakers in the region. However, these concerns have gone unaddressed.

In order to find solutions to these real-world problems that are affecting residents of my district, I have been trying to speak to you for weeks, but multiple phone calls and emails from my office have been ignored. This conduct is wholly unacceptable.

Transparency and accountability are fundamental pillars of a healthy democracy. When an unelected agency head will not respond to a sitting state senator, that agency is not being transparent nor accountable; it is hiding and abdicating its responsibility to the people of New York.

The GLOW WDB's concerns are legitimate and deserve to be addressed. The WDB plays a tremendous role in our Western New York economy, and also serves as a great model for the Governor's "shared services" push by spreading resources among four counties. This organization should be celebrated and provided with all necessary assistance by your department, but this has not been the case. By ignoring my many attempts to speak, your agency has become unresponsive to the needs of communities it is supposed to serve.
