Dear Governor Cuomo:

Thank you, again, for your administration's continued and extraordinary efforts throughout this COVID-19 response.

In particular, thank you for your ongoing leadership in recognizing the essential workers on the front lines throughout our communities who, day in and day out, night after night, are providing truly courageous, heroic, inspiring, selfless, and life-saving service. Their commitment to our common good has been remarkable. The very fact that those workers unable to work remotely are risking their personal health and safety to protect the health and safety of New Yorkers at large deserves and demands our recognition and, more importantly, support.

Recognizing this service in these unprecedented times, then, we appreciate this opportunity to urge you to immediately provide an exemption for essential workers unable to work from home, and unable to take adequate social distancing precautions on the job, from your freeze of their scheduled two-percent salary increase. These include corrections officers, law enforcement officers, nurses and other public hospital staff, and direct caregivers in nursing and group homes, and mental health care facilities.

Of course, this list doesn't cover everyone on the front lines, but we know who they are. It's the least we can do to show our respect for and admiration of their personal sacrifices.

For example, our state corrections officers, without the provision of PPE, are being required to move hundreds of inmates to and from cafeteria, recreation, commissary, and even religious services (services that, by the way, are not allowed to be attended by the public at large in communities throughout New York State at this time). As you know, our correctional facilities are not immune and have been directly infected with COVID-19.

In short, we hope you will agree that New York needs to put actions of support behind our words of support for the state's essential workforce working daily on our behalf.

Thank you for your consideration of this request, and thank you again for your own service and the service of your administration throughout this public health crisis.
