According to the "She Built NYC" public nominations, Mother Cabrini received 219 votes, more than double the second-place vote recipient, Jane Jacobs (93). However, Mother Cabrini was not included in those selected to have a statue built in their honor.

I am bringing this to your attention not only as the State Senator for the 15^{th} District, but also as the President of the Conference of Italian-American State Legislators.

As I am sure you know, Mother Cabrini was an Italian-American, who founded the Missionary Sisters of the Sacred Heart of Jesus, which was a major support to Italian immigrants here in the United States. The people's decision to vote for Mother Cabrini certainly has merit. She is recognized as the first American saint, after becoming a naturalized citizen, and founded a total of 67 institutions that were vital in shaping not only New York, but other states as well.

I find it odd and questionable that "She Built NYC" would ask the public to nominate women they would like to see honored and then not include, but actually ignore, the public's overwhelming winner. I, along with some of those who voted for Mother Cabrini, would like an explanation as to why she was not part of the final selection and respectfully urge your reconsideration of Mother Cabrini.
